*******ENTRY RULES*******

1. All entry blanks and fees must be postmarked by January 23, 2026, hand deliver January 31, 2026 to Linnea Botelho.
2. FULL PAYMENT MUST ACCOMPANY ENTRY BLANK or a **\$25 fine** may be assessed. There is a **\$25 returned check fee**. All fines must be paid in full prior to participation in this rodeo.
3. Contestants must be able to compete on both days! **IF YOU CAN'T COMPETE ON BOTH DAYS (INCLUDING SLACK), DO NOT ENTER!**
4. #4 Dally: Both partners combined must not exceed #4. Ropers will be using ACTRA Numbers. If you do not have an ACTRA Number, please contact Linnea Botelho at 808-960-1864.
5. Century Roping: Both partners age must equal 100 or more, minimum age 50 years
6. Double Mugging: Rope must pass over calf's head.
7. Calf/Junior Bull riders: 7 to 12 years. **Helmet and safety equipment recommended!**
8. Ranch Saddle Broncs: Regular roping saddle must be used
9. All rough stock events-2 helpers only allowed on bucking chutes per contestant. Helpers must be in proper rodeo attire.
10. Sheep Riding: 6 years old or under. Weight of child must not exceed 50 pounds. **Helmet recommended. No rigging.**
11. Paring up of partners will not be allowed. Do not leave your partners name blank.
12. ALL CONTESTANTS MUST BE READY TO COMPETE WHEN CALLED UPON. IF CONTESTANTS ARE NOT READY WHEN CALLED, STOCK WILL BE TURNED OUT AND/OR A NO TIME WILL BE GIVEN.
13. Champion buckles will be awarded on **Sunday immediately after the event**. Be prepared to accept awards in the arena at this time.
14. All around saddles will be **based on points**. In case of a tie, **a tie breaker will be based on the money won**. **Events for Cowboys:** Open Roping, #4 Roping, Po'o Wai U, Double Mugging, Tie Down Roping, Bull Riding, Bronc Riding, Kane/Wahine Mugging. **Events for Cowgirls:** Barrels, Steer Undecorating, Breakaway, #4 Dally, Kane/Wahine Ribbon Mugging, Wahine Mugging.
15. **No abuse of livestock in or around the arena will be tolerated. Offenses may result in disqualification.**
16. Judges decision will be final. **NO PROTEST ALLOWED.**

Any quarreling, disputes, threats, acts of violence or other disorderly behavior, before, during or after the rodeo on the Alvin "Al" Cabral Rodeo Arena premises involving a contestant or their representative(s) with rodeo officials, parking attendants, security, spectators, or other contestants, may result in the immediate disqualification from all events , forfeiture of prize money and/or eviction from the premises. Appeals should be brought to the direction of Hawaii Horse Owners president, Rob Sanborn, his decision is final and cannot be further appealed.

*****Rodeo Attire*****

Cowboy hats, Western shirts (full button front) or HHO 2026 T-shirt (no other T-shirts allowed) must be worn by contestants before, during and after the show, as well as during slack. Short sleeves are permitted. NO tennis shoes, NO Cleats, NO caps except HHO 2026 Cap.

*******WAIVER*******

Covers all show and rodeo aspects and all areas of the Pana'ewa Equestrian Center for ALL rodeo days ~ Includes Entire Park, Grand Entry, Rodeo & ALL Events with or without Horses, Cows, Bulls & Sheep ~ I, the undersigned, understand that Hawaii law (Act 249 1994 Hawaii Legislative Session, effective June 29, 1994) limits the civil liability of persons sponsoring equine (horse, pony, hinny) activities. I understand that there are inherent risks of injury, including death, when participating in an equine activity with horses, which risks include, but are not limited to,(1) the propensity of an equine to behave in ways that may result in injury or death to persons on or around them;(2) the unpredictability of an equine's reaction to things such as sounds, sudden movements, and unfamiliar objects, persons, or other animals;(3) hazards such as surface and subsurface conditions;(4) collisions with other equines or objects; and (5) the potential negligence of another participant, such as failing to maintain control over the equine, or not acting within the participants ability. Knowing and under-standing the risks of participating in an equine activity, including injury and death to my person and damage to my personal property, I expressly choose to assume these risks. Further, on behalf of myself, my heirs, successors, representatives, and as-signs, I hereby unconditionally release any and all claims and causes of action against the equine activity sponsor, Hawaii Horse Owners, Inc. and it's officers, directors, representatives, and show personnel, for any injury, including death, and for any damages to my personal property, which I may incur as a result of my participation in this equine activity. If the undersigned is the parent, guardian or representative of any minor participating in this equine activity, the undersigned agrees to indemnify the Hawaii Horse Owners, Inc.(including its above-described related persons and entities) from any and all claims and causes of action brought by or on behalf of said minor at any time. I also agree to abide by all rules and regulations set forth by the Hawaii Horse Owners, Inc. I, THE UNDERSIGNED hereby the County of Hawai'i, HHO and its employees, agents, contractors, etc. for the irrevocable right and permission to use, publish and exhibit any photographs, videotapes, media, etc. that is taken of me at the Pana'ewa Stampede Rodeo. I release the above from any claim or any liability in connection with the use of the photo or media taken.
