**\*\*\*\*\*ENTRY RULES\*\*\*\*\***

- 1. All entry blanks and fees must be postmarked by May 1, 2026, or hand delivered by May 9, 2026. Contact Linnea or Freline 808-938-8584 for hand delivery.** Entry blanks must be filled out completely with all contact information or the right of a mailed refund or payment is waived.
- All contestants must stop at the entry gate so the attendant may check the name on the contestant list. The gate opens at 5:30 am. Gates will close at 7:00 pm, the arena will be cleared by 8:00 pm.
- 3. FULL PAYMENT MUST ACCOMPANY ENTRY BLANK or a \$25 fine will be assessed. There is a \$25 returned check fee.** All fines must be paid in full prior to participation in this rodeo.
- Contestants must be able to compete on all 3 days!
- IF YOU CANNOT COMPETE AT ALL SCHEDULED TIMES (INCLUDING SLACK), DO NOT ENTER!**
- #4 Dally: Both partners combined must not exceed #4. Ropers will be using ACTRA Numbers.
- #4.5 Century Roping: Both partners' age must equal 100 or more, minimum age 50 years. Both partners combined must not exceed 4.5. Ropers will be using ACTRA Numbers. Call Linnea Botelho if you do not have an ACTRA number.
- Double Mugging/Wahine Calf Mugging: Rope must pass over the calf's head but catch as catch can.
- Junior Bull riders: 7 to 12 years. **Helmet and safety equipment recommended! We have the option to cancel the event if there are less than 5 riders.**
- John Miguel Ranch Saddle Broncs: Regular roping saddle must be used
- All rough stock events-2 helpers only allowed on bucking chutes per contestant. Helpers must be in proper rodeo attire.
- Wahine Breakaway: Bell-Collar Catch only.
- Calf scramble: Contestants must provide their own rope. **CANNOT ENTER IF CHILD ROPES OFF OF A HORSE**
- Sheep Riding: 6 years old or under. The child's weight must not exceed 50 pounds with riding gear. **MUST WEIGH IN WITH LINNEA IN THE RODEO OFFICE PRIOR TO RODEO. Helmet recommended. No rigging. (If sheep available)**
- Tie-Down Roping: Rope must pass over calf's head but catch as catch can.
- Pairing up of partners will not be allowed. Do not leave your partner's name blank.
- ALL CONTESTANTS MUST BE READY TO COMPETE WHEN CALLED UPON. IF CONTESTANTS ARE NOT READY WHEN CALLED, STOCK WILL BE TURNED OUT AND/OR A NO TIME WILL BE GIVEN.**
- Champion buckles will be awarded on **Monday immediately after the event.** Be prepared to accept awards in the arena at this time.
- All around saddles will be **based on points.** In case of a tie, **a tie breaker will be based on the money won.**
- No abuse of livestock in or around the arena will be tolerated. Offenses may result in disqualification.**
- The judge's decision will be final. **NO PROTEST ALLOWED.**

**Any quarreling, disputes, threats, acts of violence or other disorderly behavior, before, during or after the rodeo on the Honokaa Arena premises involving a contestant or their representative(s) with rodeo officials, parking attendants, security, spectators, or other contestants, may result in the immediate disqualification from all events, forfeiture of prize money and/or eviction from the premises. Appeals should be brought to the direction of Hawaii Saddle Club president, Billy Andrade, his decision is final and cannot be further appealed.**

**\*\*\*Rodeo Attire\*\*\***

**Slack and show: Cowboy hats, HSC 2026 Cap, Western short or long-sleeve shirts with full button front or Hawaii Saddle Club 2026 T-shirt (no other T-shirts allowed) must be worn by contestants before, during and after the show, as well as during slack roping.. NO tennis shoes and NO Cleats.**

**\*\*\*\*\*WAIVER\*\*\*\*\***

By signing this waiver, I agree to indemnify hold harmless and defend the Hawaii Saddle Club Inc. and the event sponsors for all days of the event it's/ their owners, shareholders, limited partners, general partners, heirs, successors, officers, directors, principles, employees, agents, representative and show personnel, from any damages, attorney fees and costs which may incur as a result of my participation as a contestant or a spectator of an event which may cause personal injury or property damage to myself or to any other person or property!.. I undersigned, understanding the Hawaii Law (Act 249, 1994 Hawaii Legislative Session, effective June 29, 1994) limits the civil liability of persons sponsoring equine activities. I understand there are inherent risks of injury including death when participating in an equine activity (all types of livestock to include but not limited to: horses, cattle, bulls, broncs, sheep), which risks include but are not limited to (1) the propensity of an equine to behave in ways that may result in injury or death to persons on or around them, (2) the unpredictability of an equine's reaction to such things as sound sudden movement unfamiliar objects, person, or other animals, (3) hazards such as surface or subsurface conditions, (4) collisions with other equines are objects and (5) The potential negligence of another participant such as falling to maintain control over the equine, or not acting within the participants ability. The undersigned agrees that this instrument is a legal contract and is binding on his/her heirs and assigns. I expressly choose to assume these risks further on behalf of myself, my heirs, my successors, representatives, and assigns. I hereby unconditionally release any and all claims and cause of action against equine activity coordinator Hawaii Saddle Club Inc. If the undersigned is the parent, guardian or representative of any minor participating in this equine activity, the undersigned agrees to indemnify the above described equine activity sponsor (including its/their above describe related persons and entities) from any and all claims and causes of action brought by or on behalf of said minor at any time. I also agree to abide by all rules and regulations set forth by the Hawaii Saddle Club Inc.
